# Introduction

Since antiquity, public spending has been financed by levies on the wealth produced, taxes.

These levies were totally arbitrary, increased by the levies made by the collecting intermediaries, and were much higher than the needs of the king, lord or other chief who had decided on a public expenditure, including its maintenance.

The world is moving forward and progressing but is gradually becoming aware of all this.

The world's people are learning to read and write.

Medicine progressed at a rapid pace and in the eighteenth century an awareness developed that is called the "Age of Enlightenment". The sciences are developing rapidly.

This awareness, added to other deep causes, made the French Revolution inevitable.

# And the Estates General led to

the Declaration of the Rights of Man and of the Citizen.

# "Article 1

Men are born and remain free and equal in rights. Social distinctions can only be based on common utility. »

As a result, their first and fundamental right is their right to vote, so each person must have one vote. Therefore, all representatives should be elected by the same number of voters, the majority then equal to half plus two because one representative has fewer votes than all the others.

# "Article 13

For the maintenance of the public force, and for the expenses of administration, a common contribution is indispensable; it must be equally distributed among the citizens, on account of their capacities. »

Contribution in proportion to revenues.

# "Article 16

Every society in which the guarantee of rights is not assured, nor the separation of powers determined, has no constitution. »

This text lays down the fundamental principles of the functioning of a nation.

But in 1789 it was not possible to calculate the "faculties", the income of each person. Electricity is being born, the industrial revolution, with all its inventions, will soon occur. And the world continues to move forward while waiting to be able to apply the principles proclaimed.

In 1945, the "crime against humanity" was proclaimed after the horrors of the war.

In 1948, the nations of the world took the Declaration of the Rights of Man and of the Citizen as a basis and added the word "universal" to proclaim "the Universal Declaration of Human Rights".

And, marvellously, 30 years later, humanity invents the "World Wide Web", the Internet, based on computerization, which gives birth to a tsunami that is only growing and which is far from being at its peak.

Tomorrow, the slightest secret – professional, medical, confessional, manufacturing, etc. – will seem so obsolete that it will be laughable. And far from offending us, this knowledge will bring us so many benefits that we will always want more, the wave of the Internet tsunami is very far from having reached its peak.

So, carried by this surge, everything today has gradually been put in place so that the will of the deputies of 1789 and their successors can easily carry it out. It takes a year.

And when this is done, then we will be able to create the single world currency, as the Euro has so easily done. The Internet tsunami is far from being at its peak.

# The root cause of all our problems is the object tax.

# What is object tax?

It is the tax on any object or service that circulates, that changes hands.

It is the tax that has different names: VAT 20% and others, taxes on petroleum products 70%, at the variable rate according to the nature of the object, taxes on movements, commissions on receipts and debits, which is imposed <u>identically on rich and poor</u>. This causes impoverishment and means that the more GDP increases, the more poverty increases.

# This is the bulk of the state's revenue.

It is a tax collected even though we do not know its amount or what we are going to do with it.

These receipts of the state are several times what the state needs but are well hidden to do what one wants.

First, for cash allocations, therefore tax-free, in the form of special funds, bonuses or other endowments.

But also for uses diverted by unforeseen salaries or contracts, global envelopes without justification.

Thus, far too many spending decisions are not the result of deliberations by democratically elected assemblies.

We need to implement an equitable program.

Enterprises are all categories of enterprises, the individual worker, the craftsman, the small enterprise, the medium and the large enterprise. Everything must contribute to facilitating wealth creation.

So, for the company, no tax, no formalities, no social charges, no various and varied taxes. This is so that all its energies can be devoted to the creation of wealth.

# The redistribution of the wealth created is done through the payment of wages.

So to create a business, from individual entrepreneur to very large company, no formalities or expenses, it is enough for an individual to register on the website of the ministry and he will be assigned a business number that will automatically give him a bank account of France for the company.

The company will obviously have to comply with all the regulations in force.


Travel expenses will be regulated.

A company will only be able to buy or rent commercial vehicles that must bear the company's logo in 30cm high characters on the 4 sides.

It will have to borrow at the maximum rate of that of the Bank of France, the latter committing to lend at this rate.

It will only be able to devote a maximum of 1% of the payroll to advertising costs or advertising financing.

It will have to comply with a homogeneous scale of wages.



**E030** It is no longer permissible to tax until the use of the tax has been determined, the opposite must be done.

E088 The public good is inalienable. Past alienations are null and void.

Public is any space that can be freely used by two or more people who need it to get from one point to another. Also public is any space that is useful for two or more. Any movable or immovable acquired or held by the State is also public.

Opening up is the typical example of the private good becoming public.

# E031 EXPENDITURE

To get there, let's see the steps, starting with government spending:

Their starting point is a budget established throughout the year, voted by MEPs at the end of the year.

E032 They set a surplus to build up a reserve in case of unforeseen need, which makes it possible not to create exceptional revenues.

E033 The expenses are proposed by the various assemblies throughout the year for the following year, then integrated and validated in the budget voted by the National Assembly at the end of the year for the following year.

# E034 REVENUES

As for the revenue, it is intended to cover the voted budget

E035 At the end of the year, we determine the percentage of each represented by what each has received out of the total received by the French in their entirety.

This rate is applied to the amount of the budget voted at the end of the year.

Each month the state deducts a single sum, a 12th, from the resource report equal to the percentage of each, the UNIC contribution to the Budget of the State: CUBE.

<u>14 simple measures that are very easy to implement</u> for better social justice and an end to poverty.

# E038 MEASURE 01 CONTROL OF FINANCIAL FLOWS

Allocation of two existing areas not currently used in international interbank exchange systems. International consultation possible so as not to duplicate work. Create a normalized pattern table of operations in addition to today's free pattern and create a table of a standardized transaction nature.

# E042 MEASURE 02 CONTROL OF FINANCIAL FLOWS

Abolition of cheques, including foreign cheques of course. One-month period.

# E043 MEASURE 03 CONTROL OF FINANCIAL FLOWS

Immediate abolition of the issuance of fiat money (coins, banknotes) with in the short term abolition of circulation as soon as the terminal equipment is completed. Including for foreigners usually all already equipped with bank cards.

# E048 MEASURE 04 CONTROL OF FINANCIAL FLOWS

Creation of the "MIROIR" operation: this is the one that banks will have to send to the Bank of France and which concerns any entry from the account of a person or company other than the holder who receives this operation.

The mirror operation is the one that has not yet passed through the Banque de France circuit and is used to count once and only once each operation when entering.

**E084** Transactions originating from an account located abroad and collected at a bank will be recorded as "incoming" in all cases.

**E087** MEASURE 05 CONTROL OF FINANCIAL FLOWS Creation of the "France" network with the payment card that also supports the CPU for the French and managed by the bank of France: total free for individuals and companies.

**E040** For individuals, and exclusively for them, allocation of a deferred debit credit card on request and free of charge. On the France network.

**E044** MEASURE 06 CONTROL OF FINANCIAL FLOWS Creation of the Universal Personal Card including everything: passport, driver's license, vital card, etc., bank card of the France network. It will be able to integrate other networks at their request.

**E039** MEASURE 07 CONTROL OF FINANCIAL FLOWS Allocation to any person and company of a computerized account Bank of France free and without obligation of use but on which will be accounted for the "mirror" operations, in addition to those of the current operation.

This account will provide all the data necessary for the management of an individual and a business.

# E041 MEASURE 08 CONTROL OF FINANCIAL FLOWS

For a business or a business, free debit and credit transactions. For the "France" network. For business not yet equipped with a payment terminal, free allocation of a card reader. Short deadline not to delay the removal of species.

- **MEASURE 09 CONTROL OF FINANCIAL FLOWS** Are maintained only the following financial transactions: transfers and direct debits issued by individuals and companies, as well as by the State. Card payments. The levies must be visible 7 days before the deadline and enforceable. Prohibition of cash movement.
- **MEASURE 10 CONTROL OF FINANCIAL FLOWS** The banks' competences are extensive and exclusive: insurance, financial transactions, credits, securities.

As such, insurance companies will be supported if they wish to become a full-fledged bank or transform their business.

- **MEASURE 11 CONTROL OF FINANCIAL FLOWS** Guarantees on real estate or other will be replaced by guarantees on France bank account. Obviously there will be an impact on the real estate market with a large supply which will have a direct consequence on the improvement of purchasing power.
- **MEASURE 12 CONTROL OF FINANCIAL FLOWS** Abolition of company cards, abolition of overheads. Travel expenses must follow rules and be paid by the person concerned. They can be reimbursed by the company according to certain rules. These refunds will therefore be "entrants" participating in the cube's base. Before, it seemed like we would be "taxed". "Food expenses" can no longer be reimbursed.
- **E049** MEASURE 13 CONTROL OF FINANCIAL FLOWS In the short term prohibition of circulation of non-personal foreign cards. Blocking at borders and terminals.
- **MEASURE 14 CONTROL OF FINANCIAL FLOWS** Companies will not be able to hold, rent, buy, use products (consumables, furniture and buildings) and services not strictly necessary for their activity. Automatic control when entering the payment.

## E090 WORK

Any hiring or debauchery must be the subject of an authorization, the labour inspector must give his answer 72 hours after he has received the last elements.

All employees must report themselves at their place of work, at the beginning and at the end. Computer applications available on his phone will allow him to do so and thus we can make automatic a lot of information: presence, overtime, place and working conditions, etc.

A "boss" will no longer be able to ask to "stay a little" without it being counted.

For example, an entrepreneur will not be able to employ a person from his company at home.

If the person leaves his phone in his company as a decoy, it will first be an embarrassment for him and it will expose him to heavy penalties, but these sanctions will protect employment in general.

# E053 PENSIONS

The principle is that everyone has their own pension funds and can control and manage them.

In salaried activity 10% minimum is paid into a blocked "retirement" personal account. This account may generate interest.

The employee can choose to increase the rate of deductions but this savings will follow the same regime and will be blocked. Only the choice of each of cessation of activity or a serious event can make it possible to ask the bank to lift this blockage, modulated in time and amount. An advisor to the tax authorities authorizes the bank.

This system makes fundamental changes to the current system and a transition period is needed.

This transition will have the following bases: estimation of the amount of pensions in the current situation up to the age of 100. In estimating this amount, everything must be taken into account: bonuses, structural overtime, etc. but not overhead costs or benefits in kind that disappear.

This amount, once estimated, is paid each month in equal instalments spread over a period of 10 years, to the "retirement" account of each.

This amount follows the same rules as normal operation.

**E054** commercial activity, competition, advertising. Individuals or companies, commercial and non-commercial, will have to obtain a broadcasting authorization.

**E091** Past or future relocation must be authorized by the Ministry of Finance jointly with the Ministry of Industry or Agriculture. Companies that do not comply with this rule will commit a "financial crime", their company will be seized. Companies that have relocated, if they have not obtained an authorization, will have to indicate in detail their relocation plan to the Ministry of Finance, which will delegate three agents on site until the end of the relocation.

# E092 CREDIT

The rate on credit or investment will be the total interest paid or received in relation to the total amount. It will be net of all costs.

The Bank of France will offer individuals and businesses a lending rate of 3%, The Bank of France will offer individuals and businesses a 2% rate of pay

Only banks will be able to carry out this activity.

Companies will be able to borrow freely inside the France or outside a bank authorized in France, but at a rate that may not be higher than that of the Bank of France.

E055 CONSTRUCTION

**E056** All construction must be the subject of an application for a building permit.

**E057** With the application for a building permit, it will require a balance sheet, architectural, utilitarian and financial

**E058** Architects of France buildings will have to issue detailed, reasoned and detailed opinions, obligatorily and in any case, classified or unclassified sites.

**E059** These opinions can only be advisory, both for private and public buildings. For the latter it is the local assembly concerned that will have to vote, it will have to justify its decision, either by relying on the advisory opinion of the architect of the buildings of France, or by a detailed motivation.

# E060 SOCIAL HOUSING IS THE CONCENTRATION CAMPS OF THE POOR

Collective construction programs for homes or activities will have to have their financial balance sheet cover ten years, when submitting their application for a building permit. This assessment must show the real usefulness and quality of the construction.

The goal is to allow everyone to be, if he wishes, the owner of his home, and to be helped while leaving the choice of the place and nature of the property acquired.

Aid should cover financing, the quality of housing, the choice of location and mobility opportunities.

The elimination of all taxes and levies will largely allow this. As well as buildings owned by "pro" investors to speculate.

**E061** RESEARCH will be able to rely on increasingly powerful computers thanks to quantum physics and nanoconductors.

#### E027

Practical consequences for a child aged 0 to 15

Declaration of birth by a doctor who mentions the sex, date, time, names of the father and/or mother and the given first name. The doctor takes the blood type and DNA code as soon as possible and records it as soon as possible. Made on the official website of the state, this registration entails the attribution at birth of a passport and a universal personal card, as well as a bank account Bank of France for which the parent or parents are responsible.

This card connected to the France network allows you to control acquisitions using the barcode. It ensures the payment of vital needs, adapted to each age and each situation.

From the age of 7 the child may have or ask his parents for a certain autonomy.

We can buy baby jars but not jewelry. 1 tablet is assigned to each child at the entrance to the school, given to his parents.

**E062** Quantum sciences will be developed "on a forced march".

**E063 COMPUTER EQUIPMENT** will be brought to the levels of the most developed countries, in terms of wiring and speed. Immediate supplies will be given as a matter of priority to isolated residents who request it.

#### **E085** – ENERGIES:

**E069** nuclear: Nuclear power can only be used once safety and waste disposal issues have been resolved. In the meantime, it must be phased out, even if it is later to come back to it when the problems of safety and waste disposal have been solved.

# Natural energies are tens of thousands of times higher than current global consumption.

The natural energies are: solar, wind and hydraulic.

Every building receives these three energies in all parts of the world.

The first solar houses are more than half a century old!

The whole objective of "energies de France" must be to develop individual sensors adapted to each region and allowing each to be autonomous.

No more heavy electricity and gas bills, or even fuel oil no more oil and gas giants with their platforms and pipelines

This will be done in stages but as soon as possible, in order to remove nuclear and fossil fuels from our environment. Fossil materials will be reserved for sustainable uses.

#### E064 MEANS OF COMMUNICATION

All communication channels will be free: motorways, telephony, Internet.

#### E066 SOCIAL SECURITY

All medical and surgical expenses are covered by the State and appear on everyone's income slip for the knowledge of their importance.

Including glasses, teeth, hearing aids and others.

For non-nationals only emergencies will be covered by the state.

# E065 ARMEE

The army will intervene for missions other than combat but requiring its intervention such as disasters, law enforcement, territorial security.

The army will only employ military personnel receiving military training adapted to the function, the transition of existing civilian personnel can be modulated.

Controls of air, sea, land and other traffic will be carried out by the army, mainly the Gendarmerie, and in case of specific needs or reinforcement, by other weapons.

## E067 MILITARY SERVICE

A two-year voluntary military service, paid twice the minimum wage, is set up and open to young men and girls aged 18 to 22, on the basis of an aptitude examination. The main purpose of this military service is to facilitate integration into civic life. And this military service will give an additional element to the young person in his CV.

This military service will provide, if necessary, the necessary basic training, driving license, first aid, etc.

# E068 ADDICTIONS

There will be an obligation of care and follow-up in case of addiction to tobacco, drugs, alcohol, gambling or other. It is the country's duty to protect everyone from themselves.

**E093 VIOLENCE**: it is a moral, physical or any kind of pressure exerted by one or more people on one or more people.

If there is murder, the penalty is automatically life imprisonment.

If there is cruelty, even without death, to a woman, a man or an animal, the penalty is automatically life imprisonment.

# E071 TELEVISION

Interactive theme channels will be created to provide a permanently available service.

Permanent channels of information with possible targeted consultations.

Channels that support local, regional and national employment. Chains specialized by trades.

These channels will of course be particularly in the front line during the elimination of unemployment but they will continue to improve the match between supply and demand.

# E052 - CRIME AGAINST HUMANITY

Crime against humanity was defined in 1945.

To be convinced, if it were necessary, let us look at what is happening in the other direction, the one where money is given, during general increases, that of civil servants, that of the SMIC or others.

When the state decrees increases, it expresses it as a percentage of the salary. So we do not change the balance, the gap between the rich and the poor keeps the same proportions.

If we applied the same system as VAT, the poor and the rich would receive the same increase: for example 50 €. The poor is what he usually receives but for the rich, this 50 € on a salary of 10,000,00 € or more is a joke?

The presidency of the Superior Council of the Judiciary, therefore the power to appoint magistrate whoever he wants where he wants. He also has full powers over the action of the prosecutor's office.

The possibility of dissolving the popularly elected National Assembly. The power alone to promulgate laws, and to refuse to promulgate a law voted by the representatives of the people.

These two powers are in addition to its primary and normal function:

However, with the exception of the presidential election that elects a dictator, in no other election is the principle of "one person, one vote" respected.

E009 It must be done differently to have "one person, one e-vote"

Registration on the electoral roll becomes automatic. Each is assigned to his commune of residence, to the main city of his department, his region, his legislative constituency. The computer assigns the same number of voters to each canton, each regional constituency, then legislative, and necessarily in each zone a representative has fewer voters than the others, resulting in a majority of half plus two votes.

The balance of the number of voters is ensured by allocating the surpluses to the nearest city, each voter having the possibility of changing this allocation only once per election by one of his choice, even remote, up to three months at the latest before the election. Thus we can take note of the new assignments.

Candidates for the various mandates must register without conditions other than those of age and enjoy their civil and political rights.

#### **E010 MUNICIPAL**

First of all, the list ballot makes a selection that prevents everyone from being represented. We know the first two or three, the others not at all. Then the electoral law, variable, defines for example that 40% of the votes give 60% of the seats of councillors: bonus to the strongest and woe to the defeated. "One person, one voice" does not exist.

We need individual candidates, a one-round ballot, free registration of candidates on computers, councillors in proportion to the number of inhabitants. On takes the first with a greater number of votes, if there is a tie for the last two of the list we take one more councillor.

# **E011** DEPARTMENTS

Each departmental councillor represents a canton with always a different population in number. Obviously, the electoral "kitchen" makes it possible to cut and redivide thecantons. The result is that we have an assembly where each representative has one vote, but is elected by a different number of voters. Again, "one person, one voice" does not exist. This level of representation no longer seems necessary because it duplicates the regional level.

All but one canton must have the same number of voters. There must be a one-round ballot, the one with the most votes is elected, drawing lots if the first two are tied. In assembly the majority is half plus two votes.

#### **E012 REGIONAL**

With the list vote, we have the same situation as for the municipal elections.

#### **E013 LEGISLATIVE LAW**

We have a similar situation to the departmental ones: a deputy from a chic district of Paris is worth 3 deputies of 9-3.

#### **E014 SENATORIAL**

They have little representativeness: they are elected by bracket and period, by indirect suffrage so not even by the people themselves but by "grand electors" as in the Middle Ages. The assembly has no power – fortunately – but then one wonders why pay so much for it and therefore it is destined to disappear.

Why not change senators to members of Parliament. Today we have one MP per 100,000 inhabitants, we would have twice as many MEPs and therefore one for every 50,000 inhabitants, with twice as much knowledge of the field.

# **E015** ELECTORAL PROCESS:

Obviously we can no longer vote with shells as in antiquity, we are in the twenty-first century all procedures must be computerized and free.

Elections are held every four years. Each person can only apply for one mandate, and not consecutive to another, or twice the same. The elections will last 24 hours in all the territories composing the France. We will have the complete results at the end of these 24 hours, the process would begin on Saturday 12:00, Paris time, and end on Sunday at 12:00 CET.

**E086** In the event of incapacity of the President of the Executive, the duration of the incapacity: if this period exceeds 30 days, general elections shall be held.

# E016 EUROPE

**E017** There is no democracy when Europe forces Ireland to vote again because it voted "wrong" by voting no to Europe.

**E018** There is no democracy when the France says no to the European Constitution and the leaders pass a "sub-law" by the deputies and not by referendum.

The integration of the France into the European Union is therefore not legitimate and the France could legitimately leave it.

**E019** The France is in Europe, it will always be part of it but will not submit to any principle that would be contrary to its interests and equity.

**E020** The France will keep the name "euro" - it is its founder - for its currency but will not participate in any financial organization, whether European or international. It will guarantee payments in a third currency of the creditor's choice at the time of the order. It will not ask for any guarantee in any currency.

- **E021** The France will no longer participate in any expenditure contrary to its interest: parliament, operation, etc.
- **E022** It will immediately repatriate French civil servants in their original assignment and salary. If necessary, French civil servants will be able to continue to carry out their duties in teleworking.
- **E023** Naturally the France will be able to decide without consulting its partners on any measure that does not have an impact on them: for example, it will abolish VAT without consultation.
- **E024** It will not contribute to the CAP in its current form: the France will contribute to an aid to agricultural holdings with an income of less than €500,000.00 by consolidating the holdings and all their owners, their registered offices, their farm premises. It considers that only farms in difficulty, not surplus enterprises, should be helped.
- **Each** assisted company will have to be placed under full supervision, with three officials on site with an office and computers connected to the company's information systems as well as bank accounts, obviously only for consultation. The sole purpose of this guardianship is to help the entrepreneur regain his autonomy without further assistance.
- **E026** Today 80% of the CAP is perceived by large groups which distorts competition, forces the sale of small ones, with an action on prices.

The law must provide for the minimum penalty that applies in the event of an infringement.

**E072** The death penalty has been abolished, following the example of many countries, although there are still too many that apply it. This abolition is obviously a good that allows us not to show barbarism.

Murder is a death sentence decreed by an individual who has made his law on his own. It can only be punished by life imprisonment, the dead person will not come back.

It will not practice reciprocity if it has been refused and will require a reciprocity agreement each time.

# CONSTITUTION

# **Preamble**

The French people solemnly proclaim their attachment to the rights of man and of the citizen as defined by the Declaration of 1789, supplemented by the Declaration of 1945 establishing the concept of crime against humanity and by the Universal Declaration of Human Rights of 1948.

The French people solemnly proclaim that Woman and Man take precedence over Society.

Society is made by them and for them. This society is necessary to enable them to live together and it is at their service to protect them, to guarantee individual freedoms that limit the freedoms of others. The citizen has the duty of good citizenship.

The France is a secular democracy, its language is French, its flag is Blue, White, Red, its anthem La Marseillaise, its motto is "Equity, Democracy, Justice". Its principle is: government of the people, by the people and for the people, each with one vote.

The public good is inalienable. It is under the responsible custody of each citizen.

The French people, as a whole, entrust the Public Service, led by the executive power, with the establishment and monitoring, to ensure that each of its members:

a remunerated activity allowing decent living conditions,

decent housing,

free access to all health care,

free access to education, including food, clothing, housing, transport and the personal and collective tools necessary for studies.

It ensures that each individual has free access to electricity and water, for which he pays the price of his consumption.

It ensures that everyone has the possibility of having access to all existing means of communication free of charge.

## Title I: Democracy

Art. 1. – The France is a Democracy based on the principle of one person equals one vote which applies in all cases of public representation. In the assemblies each representative must be elected by the same number of voters. Decisions are taken by an absolute majority.

Every four years the representatives of the people are renewed.

It is secular. It ensures that everyone practices the religion of their choice in places of their choice.

It ensures equality before the law for all citizens without distinction as to sex, origin, religion or other discrimination.

The law guarantees equal access for women and men to electoral mandates and elective offices, as well as to professional and social responsibilities.

The vote to elect the representatives must be cast in one round, the largest number of votes designates the elected. The vote is necessarily taken into account, either in vote expressed or in unexpressed so-called "blank".

All French nationals of full age of both sexes, enjoying their civil and political rights, are eligible to vote under the conditions determined by law.

Art. 2. — National sovereignty belongs to the whole people who exercise it by their votes or by the votes of their representatives in local and national assemblies, and occasionally by means of referendums.

A referendum can be initiated by the executive, the legislature, the judiciary and the people. By action of their president: that of the France, that of the National Assembly, that of the Court of Cassation. The people must gather a thousand people to demand a referendum.

- Art. 3. The functioning of the institutions must be computerized and decentralized. The ministries must be located in cities with less than 200,000 inhabitants spaced from each other, as far as possible from the metropolises, none in Paris.
- Art. 4. Political parties and groups shall contribute to the expression of the vote. They train and carry out their activity freely. They cannot receive public funds. They may or may not constitute themselves as a non-commercial company.
- Art. 5. The Constitution can only be amended by referendum on the initiative of the President of the Executive or the President of the National Assembly.

# Title II - The Executive Power.

Art. 1. – The President of the France is the President of the Executive Power, Head of the Armed Forces. He is elected by all French people. He is assisted by a Prime Minister and ten Ministers who are responsible for the following ministries:

The Ministry of Life, including health, living conditions and the environment

The Ministry of *Freedom*, including security, police, respect for everyone's freedom.

The Ministry of Justice

The Ministry of the Armed Forces

The Ministry of Finance

The Ministry of Knowledge, including education and research

Department of Industry

The Ministry of Agriculture,

The Ministry of territory, including land, sea and air, infrastructure and heritage

The Ministry of Foreign Affairs

- Art. 2. Officials of all ministries are graded by their hierarchy to rise in rank. Officials of the three highest ranks are elected by the lower-ranking college.
- Art. 3. The executive power is responsible for drafting laws to propose them to the deputies.
- Art. 4. The executive power must ensure the proper functioning of the ministries.
- Art. Art. 5. In cases of desirable short deadlines, the president of the executive may request the authorization to govern by decrees from the president of the national assembly with his formal advisory opinion to each decree. These decrees are valid for one month.
- Art. 6. Death of the president of the executive: the Prime Minister ensures the interim and has general elections held within a maximum of 30 days.
- Art. 7. Serious situation for the country: in case of war, insurrection, economic blockade, pandemic or any other situation deemed serious, the president of the executive may decree a state of emergency. He set up under his presidency the Emergency Council composed of the President of the National Assembly, the President of the Court of Cassation, the three Chiefs of Staff of the Armed Forces, the Ministers of Freedom and Finance. This Council has full powers for a maximum period of 60 days that cannot be extended or renewable.

We get out of it in two ways: general election or vote of two-thirds of MPs seeing a return to normalcy.

Art. Art. 8. – In case of incapacity of the President of the executive, the Emergency Council assesses the duration of the incapacity: if this duration exceeds 30 days, general elections are held.

Title III - Legislative power.

Art. 1. – All deputies are elected by the same number of people, and, as necessarily, there is a deputy who has fewer votes than the others, the majority is half plus two votes.

Legislative power is vested in all deputies who elect a president and a council of ten members.

- Art. 2. The National Assembly may pass laws initiated by itself, by the executive power, by the judiciary.
- Art. 3. Each law must include a maximum of three articles, must not refer to any other text, must not provide for an implementing decree. It must provide for the minimum penalty that applies without further consideration.
- Art. 4. When this law is passed, it is validated by the President of the National Assembly and the Council. Validation is done by registering all MPs with their vote, including blank. As soon as it is registered, it becomes applicable.

# Title IV - The judiciary.

- Art. 1. The highest rank is the Court of Cassation. This college elects a president and a council of ten members.
- Art. 2. Magistrates must be appointed more than 500kms from their poles of attraction.

Magistrates cannot rise in rank on the spot and must change assignment every two years, at 500kms.

Art. 3. – There are three categories of courts:

Simple court for contraventions, labor disputes, commercial disputes, disputes between people. They are composed of a magistrate to judge and a clerk to set out the facts and possible sanctions.

Criminal court for more serious acts but without violence either physical or moral. They are composed of three magistrates to judge, an advocate general to set out the facts and request the appropriate sanction, and a representative of the civil party to request the appropriate compensation.

Assize Court for physical or moral violence, serious injury to the integrity of persons, cruelty to women, men and all living beings, serious damage to the integrity of private and public property, serious damage to the environment. The Assize Courts are composed of five magistrates to judge, two Advocates General to set out the facts and request the appropriate sanction, and as many representatives of civil parties as desired.

- Art. 4. It is the investigating judge of the place of commission of the facts who is in charge of the case by the investigating chamber which appoints within a period of one week two other investigating judges, these three judges will continue the investigation in a collegial manner.
- Art. 5. The truth does not suffer from obstacles at any time. Secrecy can never be asked for oneself or others. Hearings are televised and recorded. Elements of interest to the security of the country may be reserved for the knowledge of the magistrates.
- Art. 6. The Advocate(s) shall set out the facts and request a penalty. The defence then puts forward its arguments. Finally, the floor is given to the civil parties.
- Art. 7 All judgments may be appealed, suspensive or not. This appeal will be judged 500kms from the first judgment.
- Art. 8 There is no prescription in any area.

# Title V – Equity

The notion of equity was first formalized in a law when the Declaration of the Rights of Man and of the Citizen was published, but it is a feeling rooted in human nature.

Art. 1. – The executive power, the municipal and regional assemblies, and then ultimately the legislative power, say what it is necessary to do for the state to function, it is the vote of the budget. The work is distributed throughout the year and at the end of the year the National Assembly votes on the final total budget that applies for the following year.

Art. 2. —To determine the contribution that each must provide: on 31 December the entrants of each for the past year are decided. The percentage of each entrant to the total entrants is determined.

# Title VI – Work

- Art. 1. Any job to be filled in the public or private sector must be made public and be filled only after one month, or even more in the event of an appeal by a person.
- Art. 2. Only competence must be retained for the choice of the candidate. This jurisdiction will be on the public record.
- Art. 3. Hiring and dismissal are subject to authorization.
